This document and attached booklet TABS comprise the second quarterly report on the Northeast Ohio Information Exchange: Digital Infrastructure for Drone Services in Cuyahoga County, abbreviated hereafter as the NEOFIX project.

The format narrative of this document is drawn from the reporting items listed in section 4 of the agreement between Cuyahoga County and Baldwin Wallace University for funding the NEOFIX, cut and pasted as:

Recipient shall submit quarterly reports to the Clerk of the Cuyahoga County Council. Reports shall be submitted no later than thirty (30) days after the end of each calendar quarter. In each report, recipient shall provide the following:

- An itemized list of all expenditures made during the preceding quarter (see Table I below).
- 2. An itemized list of project goals achieved during the preceding quarter; (see Table II below).
- 3. An itemized list of project goals in progress as of the end of the preceding quarter (see Table II below).
- 4. An itemized list of project goals to be completed during the current quarter and an itemized list of project goals to be completed in the next quarter (see Table III below).





Summary Narrative

The third quarter report on the progress of the NEOFIX depicts uninterrupted work initially described in the original proposal to the Cuyahoga County District 2 and County Council in Fall 2022 and the first and second quarter reports submitted this past spring and summer.

Briefly, the NEOFIX is a public private partnership, where public sector first-in resources will be amplified well beyond a dollar-for-dollar return for an emerging \$10B private industry benefiting residents of the County and the state of Ohio. NEOFIX will provide public safety in Cuyahoga County with a *Common Operating Picture* of drone operations, supporting safe operations and counter-UAS. The NEOFIX puts the County and its airspace within the leading the communities in the nation, applicable as a model program for the state of Ohio.

- The first quarter work of the NEOFIX attended on identifying and organizing the stakeholder community.
- The work of the second quarter focused on building the NEOFIX instrument. The public facing NEOFIX web interface was made live (https://bw-centers-tech-partnerships.org/bw-announces-launch-of-neofix-cuyahoga-countys-new-drone-safety-platform) (in the second quarter of 2023 (June 21) and presented to stakeholders for use and refinement.
- The third quarter outputs involve buildout of the NEOFIX data base drawing on data
 provided by Cuyahoga County GIS and planning programs, and on flight and other
 ground sensor data contributed by private sector corporations. The NEOFIX is designing
 its system to enable growth to other counties in the state of Ohio, residents and other
 stakeholders.

The work outputs noted are applicable toward and complement the state of Ohio's DriveOhio Advanced Air Mobility framework (https://drive.ohio.gov/programs/aam/aam-framework).

As part of the 3d quarter outreach, the NEOFIX has presented briefings to the state house committee on Aviation and Aerospace Committee (https://ohiohouse.gov/committees/aviation-and-aerospace) and one-on-one updates to congressional staff representatives for US House Districts 7 and 14.

The work for the third quarter has set the conditions for individual meetings in the governor's office and separate meetings with legislators for the 4th quarter of 2023 in the state of Ohio in mid-October; a separate a legislative briefing on October 23, 2023 at Baldwin Wallace University; and briefings for the Cuyahoga County Executive and Council on October 24, 2023.





The work of the fourth quarter will involve making the case for direct support from the state of Ohio in the creation of public infrastructure. Initially the use-case focus is to support health disparity use cases and commercial application use cases for local, regional and state-wide economic development outcomes.

Third Quarter Timeline

In the period July through September 2023 content has been steadily increased on the NEOFIX website to deepen its use as a resource for drone use stakeholders in the County and region. Report

I. Third quarter NEOFIX project performance

Goal 1 To form four working subgroups drawn from stakeholders identified during first quarter

Goal 2 To design and build the NEOFIX and accessible to the public.

Goal 3 To begin marketing the NEOFIX setting the conditions for a public private partnership (PPP) regionally and across the state of Ohio

Third quarter work engaged participants from all four working groups (Data, design and configuration, sensors integration and planning; and public policy).

Outputs for the data sharing/base layers group included engagement of the County's IT/GIS heads and development of County GIS derived NEOFIX base map detail. This included access to point data from Tier 2 LEPC reports from showing facilities locations and quantity of hazardous materials on-site. Records had ESRI geocoding fields. Information was also exchanged with the Cleveland Metroparks including the protocols for a National Institute of Standards and Technology (NIST) readiness assessment for their policies and droner operations procedures.

- Outputs for the design and configuration group included use cases shared by the Cleveland Clinic; First Energy, collaboration with flight information exchanges coalescing in other states.
- Outputs for the sensors integration and planning group included favorable outreach to City of Cleveland Airports including Burke Lakefront and Cleveland Hopkins International Airports, and the airports in nearby counties with who airspace is coterminus with Cuyahoga County.
- Outputs for the public policy are slowly coming together as the NEOFIX looks to synchronize with state of Ohio initiatives involving advanced air mobility. The NEOFIX fulfills the policy niche for the state of Ohio which is looking to the economic development regions to inform and advance AAM statewide.












Flight Counts by Hour






Flight Counts by Week

BW announces launch of NEOFIX, Cuyahoga County's new drone safety platform

The digital data-sharing system aims to enhance uncrewed aerial flight safety and to drive economic growth by positioning Northeast Ohio as a leader in the drone industry.

BEREA, Ohio—Baldwin Wallace University's <u>Technology Partnerships Initiative</u> in collaboration with <u>ATA, LLC</u>, has launched the <u>Northeast Ohio Flight Information Exchange (NEOFIX)</u>, a digital data-sharing system designed to enhance drone safety, starting in Cleveland and Cuyahoga County.

NEOFIX provides real-time awareness of ground policies, infrastructure, and activities that may impact flight operations, enabling state and local public safety agencies, government entities, drone pilots, and the public to provide crucial information, promote transparency, and ensure a high level of safety and accountability in drone operations.

Filling the gaps, unlocking potential

"Our goal with NEOFIX is to create a centralized hub for flight information that empowers responsible drone use and enhances situational awareness for both operators and public safety," said Stuart Mendel of Baldwin Wallace University's Technology Partnerships Initiative.

"By filling the gap between traditional aviation charts and street maps, NEOFIX unlocks economic prospects and positions Cleveland and Cuyahoga County as drone industry pioneers, prioritizing public safety and the rights of citizens and harnessing drones for advanced emergency response." The graphic below elaborates on these promises, applicable to Cleveland, Cuyahoga County, and all of Ohio.

Transformative centralized information hub

NEOFIX is an Authoritative Supplemental Data Service Provider (ASDSP) that provides the operators of drones, which are also known as Uncrewed Aircraft Systems or UAS, with essential information for informed decisions, operational efficiency and risk mitigation. It is a centralized hub that enhances collaboration, communication, and safety for operators, public safety agencies, government entities, UAS Service Suppliers (USS) and the public. NEOFIX also offers

access to safety advisories, weather assessments, local infrastructure details, topography insights and real-time updates.

As a shared governance model and authoritative source for clearer, higher quality information that is critical for drone pilots, NEOFIX is an essential component for building a UAS Traffic
Management (UTM) System. It provides a situational awareness of the ground that is sent to service suppliers for the drone industry that are currently developing UTM systems.

These commercial UTM systems are designed to operate like air traffic control in the close reaches of the airspace. They will soon be used for drones to fly greater distances beyond the visual line of sight of their operators.



"NEOFIX represents a transformative platform that empowers drone operators with comprehensive information, ensures safe integration, and fosters the growth and advancement of the drone industry in a cost-effective manner," said John Eberhardt, the chief technology officer of ATA. "By embracing NEOFIX, operators gain critical data, promote regulatory compliance, and enhance drone safety."

Cuyahoga County leading the way

With the support from <u>Cuyahoga County</u> District 2 Councilman Dale Miller, Baldwin Wallace secured \$225,000 in funding for the inaugural year of NEOFIX from the federal COVID-19 stimulus package, which was part of the American Rescue Plan Act. This financial support sets the stage for the successful launch and implementation of the program and positions Northeast Ohio for private investment in infrastructure, education and jobs as the industry continues to expand in the region and eventually to the entire state.

NEOFIX helps to improve the safety and efficiency of using drones in various industries to drive this economic growth. For example, drones are used in construction to inspect buildings and bridges, reducing the need for workers to perform these tasks that are often dangerous, time consuming and expensive by traditional methods. Drones fly over farmland, helping farmers survey their fields more quickly. First responders deploy drones to conduct search and rescue operations, deliver medical supplies and other emergency response missions.

Additionally, NEOFIX provides environmental benefits by creating infrastructure to support drone services in Northeast Ohio that reduce the need for larger ground transportation vehicles for deliveries. Drones are also powered by electric or hydrogen, which are cleaner energy sources. And when integrated with sensor information, drones strengthen the area's resilience against severe weather conditions and climate events, fostering a safer and more sustainable community.

Publicly-owned and governed

NEOFIX is a publicly owned digital service with data in the public domain, such as take-off and landing areas, critical infrastructure, local guidance and rules, and existing sensors. It uses an open interface for authorized users to publish key information.

A user group with representatives from state and local government and public safety agencies, service suppliers, critical infrastructure providers will govern the system and identify the types of information that can be properly and consistently described and published. Private industry partners, including Critical Ops, LLC, an Ohio-based integration consulting firm, is helping guide and shape sustainable NEOFIX operations in Ohio.

"Government data provides a common operating picture, benefiting operators and industries. As information integrators, we facilitate the flow of data to end users as public digital services," Eberhardt said. "Our model helps lower operating costs for operators, governments, and industries while addressing their needs."



House Panel Unanimously Passes FAA Reauthorization Act, Major Tech Provisions

The Transportation and Infrastructure Committee Wednesday approved bipartisan legislation to reauthorize the Federal Aviation Administration (FAA) and aviation safety and infrastructure programs for the next five years, by a unanimous 63-0 vote.

The Securing Growth and Robust Leadership in American Aviation Act was introduced on June 9 by Transportation and Infrastructure Committee Chairman Sam Graves, R-Mo., Ranking Member Rick Larsen, D-Wash., Aviation Subcommittee Chairman Garret Graves, R-La., and Ranking Member Steve Cohen, D-Tenn., and includes several tech provisions to bolster security and innovation within the Federal aviation sector.

The nearly 800-page bill will now go to the House floor for a vote, with hopes of getting it across President Joe Biden's desk before the FAA's current authorization expires on Sept. 30.

"This bipartisan bill is critical to America's global leadership in aviation, to our economy and millions of jobs, and to making the entire system safer and more efficient for all users and the traveling public," said Chairman Sam Graves when his committee passed the bill on June 14 – after two full days of debate.

The committee's legislation comes after five grueling FAA reauthorization hearings, and one nationwide ground stop when the agency's Notice to Air Missions system broke down earlier this year – sparking bipartisan concern over the agency's outdated IT systems and cybersecurity.

The House bill has four sections dedicated to improving aviation technologies and the workforce:

- Improving FAA efficiency and operations: The bill makes targeted changes to the
 organizational structure of the FAA to improve the overall efficiency of the agency, allow
 for innovation, and streamline the regulatory process;
- Growing the aviation workforce: This bill addresses workforce challenges by removing barriers to pursuing aviation careers, expanding the aviation workforce pipeline, improving training standards, and more;
- Upholding America's gold standard in safety: The bill addresses several safety issues, including the recent uptick in runway incursions, to ensure the United States, and the FAA, remain the world's gold standard in aviation safety; and
- Encouraging aviation innovation: America has been a leader in aviation innovation. Unfortunately, due to bureaucratic hurdles, endless research, and pilot programs that are not leading to the development and incorporation of new technologies, China and other countries are beginning to surpass the United States. The bill encourages the safe

yet more efficient testing and integration of new technologies, such as drones and Advanced Air Mobility, into the airspace.

"The Securing Growth and Robust Leadership in American Aviation Act is the most comprehensive aviation legislation the Transportation and Infrastructure Committee has ever approved. This legislation will help to improve the passenger experience for all travelers while laying the groundwork for innovators and new technologies to advance in America," said Aviation Subcommittee Chairman Garret Graves.

"This legislation will make the Federal Aviation Administration's structure more certain, predictable, and capable of facilitating improvements and innovations in our national airspace," he added. "These transformational changes will ensure that the United States can continue to set the gold standard in aviation safety while leading the world in aviation innovation."

So, You Want to Be a Commercial Drone Pilot?

As the commercial drone industry continues to grow, so does the demand for pilots.

According to recent reports, some 100,000 drone-related jobs will be created over the next two years as companies ramp up their uncrewed operations. Drones Propel Farming into the Future in Ohio

Farmers are using drones to improve efficiency.

Nate Douridas is the Farm Manager at The Ohio State University's Molly Caren Agricultural Center in London, Ohio.

Douridas said drone use allows farmers to rely on clear and specific data instead of forcing farmers to make informed guesses when replanting certain areas of a field or applying water, nutrients, etc.

Evan Delk is the President of Integrated Ag Services. He and drone pilot Justin Vaughn assist farmers with drone use and crop scouting. "We're using this drone technology to help farmers make better decisions," Delk said.

Within minutes, their drone and the cameras that are attached to it survey hundreds of acres of land, capturing high-resolution images, and combining them with artificial intelligence.

"It takes a wide picture and then it takes a close picture, which is where all of the real data comes from," Vaughn said.

That information is then converted it data that farmers, like Douridas, use to improve their crops and business.
